RESOLUTION OF THE GREASEWOOD SPRINGS CHAPTER

Supporting and Endorsing the Completion of a Rural Addressing System and Implementation of the Navajo Nation Enhanced Emergency 9-1-1 System through the Communications and Utilities Department of the Navajo Division of General Services.

WHEREAS:


1. The Greasewood Springs Chapter exists as a local unit of government recognized as a political sub-division of the Navajo Nation, pursuant of the Navajo Nation Code No. 26, Section (a) and is authorized to review all matter effecting the community in order to address the needs of the local residents with the authority to act in the best interest of the general welfare of its community membership; and
2. Pursuant to Resolution No. CAP-34-98, the Navajo Nation Council approved the Historic Local Governance Act, which authorized the local Navajo communities to plan develop and implement a restructuring process to improve community decision making allowing communities to excel and flourish enabling Navajo leaders to lead toward a prosperous future and improved the strength of the Navajo Nation Sovereignty; and
3. The Greasewood Springs Chapter acknowledges the need for the establishment of an Enhanced Emergency 9-1-1 System on the Navajo Nation, to improve adequate communications and expedite emergency services; and
4. The Greasewood Springs Chapter further acknowledges the need for the implementation of the Navajo Nation-wide Enhanced Emergency 9-1-1 System for any sudden occurrences of emergencies on the Navajo Nation; and
5. Furthermore, the establishment of an Enhanced Emergency 9-1-1 System will not only be beneficial to the Navajo people, but will also utilized by the Navajo Nation businesses, health care facilities, educational institutions, fire districts, emergency rescue personnel, police districts, private, Tribal, State, and Federal Government Facilities.

The Greasewood Springs Chapter hereby supports and endorses in the Completion of Rural Addressing System and implementation of the Navajo Nation Enhanced Emergency 9-1-1 System through the Communications and Utilities Department of the Navajo Division of General Services.
