## RESOLUTION OF NAHATA DZIIL CHAPTER

NDZL07-06-549

### SUPPORTING AND ENDORSING THE COMPLETION OF A RURAL ADDRESSING SYSTEM AND THE DEVELOPMENT AND IMPLEMENTATION OF A NAVAJO NATION ENHANCED EMERGENCY 9-1-1 SYSTEM.

#### WHEREAS:

1. The Nahata Dziil Chapter is certified by the Navajo Nation Council Resolution CAP-36-91 as a local governmental entity of the Navajo Nation government which has the responsibility and authority to promote, protect and preserve the interest and general welfare including the safety of its community, people, programs, and property, etc.; and
2. Transportation and Community Development Committee of the Navajo Nation by Resolution TCDCAU-66-02, approved governance certification of the Nahata Dziil Chapter's Five Management Policies and Procedures pursuant to 26 N.N.C. Section 102 (B), which permits the Nahata Dziil Chapter to exercise local governance authorities contained within 26 N.N.C. Section 103, with exception of land administration authority pursuant to 26 N.N.C. Section 103 (D)91); and
3. The Nahata Dziil Chapter is aware of the need of a Navajo Nation-wide Enhanced Emergency 9-1-1 System for any sudden occurrences of emergencies, and recognizes; and
4. The Nahata Dziil Chapter acknowledges the need for establishment of an Enhanced Emergency 9-1-1 System on the Navajo Nation, to improve adequate communications and expedite emergency services; and
5. Furthermore, the Nahata Dziil Chapter has discussed the best interested of the Chapter Memberships, and forwarded to the duly called Regular Chapter Meeting for community action June 22, 2007.


