4. Furthermore, the Pueblo Pintado Chapter genuinely believes those communities within Navajo Nation will not only benefit the people, but also public businesses, health care facilities, educational institutions, fire districts, emergency rescue personnel and police district.

NOW, THEREFORE BE IT RESOLVED THAT:




