**RESOLUTION OF THE TONALEA CHAPTER
WESTERN NAVAJO AGENCY
Resolution No. TN-04-08-07**

Supporting and Endorsing the Completion of a Rural Addressing System and the Development and Implementation of a Navajo Nation Enhanced Emergency 9-1-1 System

WHEREAS:

1. Pursuant to Title XXVI of the Navajo Nation Code, Tonalea Chapter is a certified Navajo Nation Chapter and vested the authority to plan and make decisions on matters of local concerns that are in the best interest of the Tonalea Chapter; and
2. The Tonalea Chapter is a recognized governing entity of the Navajo Nation located within the boundaries of the Navajo Nation. It is endowed with perennial responsibilities to advocate for its citizens and community within the Navajo Nation; and
3. The Tonalea Chapter is aware of the need for a Navajo Nation-wide Enhanced Emergency 9-1-1 System for any sudden occurrences of emergencies, and recognizes the lack of an effective emergency response; and
4. The Tonalea Chapter acknowledges the need for establishment of an Enhanced Emergency 9-1-1 System on the Navajo Nation, to improve adequate communications and expedite emergency services; and
5. Furthermore, the Tonalea Chapter genuinely believes those communities within the Navajo Nation will not only benefit the people, but also public businesses, health care facilities, educational institutions, fire districts, emergency rescue personnel and police district.

NOW THEREFORE BE IT RESOLVED THAT:


