**SUPPORTING AND ENDORSING THE COMPLETION OF A
 RURAL ADDRESSING SYSTEM AND THE ESTABLISHMENT
 AND IMPLEMENTATION OF A NAVAJO NATION
 ENHANCED EMERGENCY 9-1-1 SYSTEM**

WHEREAS:

1. The Upper Fruitland Chapter is a certified chapter of the Navajo Nation as listed under 11 N.N.C., Subchapter 1, § 10; and pursuant to 26 N.N.C., Section 1, (A), (B) respectively, was given the "governmental authority to make decisions over local matters, consistent with Navajo law, including custom and tradition" and be "compelled to govern with responsibility and accountability" to its chapter membership; and
2. The Upper Fruitland Chapter is aware of the need for a Navajo Nation-wide Enhanced Emergency 9-1-1 System for any sudden occurrences of emergencies, and recognizes the lack of an adequate and effective emergency services; and
3. To improve adequate communications and expedite emergency services, the Upper Fruitland Chapter acknowledges the need for a Rural Addressing System and the establishment of an Enhanced Emergency 9-1-1 System on the Navajo Nation; and
4. Furthermore, the Upper Fruitland Chapter genuinely believes that those communities within the Navajo Nation will not only benefit from the Rural Addressing System and 9-1-1 System, but so will other public businesses, health care facilities, educational institutions, fire districts, emergency rescue personnel and police districts located within and near the Navajo Nation.


NOW THEREFORE BE IT RESOLVED THAT:

The Upper Fruitland Chapter hereby supports and endorses the completion of a Rural Addressing System, and subsequently, the establishment and implementation of a Navajo Nation Enhanced 9-1-1 System, an effort by and through the Communications and Utilities Department of the Navajo Division of General Services.
