### SUPPORTING AND ENDORSING THE COMPLETION OF A RURAL ADDRESSING SYSTEM, THE DEVELOPMENT AND IMPLEMENTATION OF A NAVAJO NATION ENHANCED EMERGENCY 9-1-1 SYSTEM.

#### WHEREAS:


1. Pursuant to the "Local Governance Act", 26NNC, chapter 1, subchapter, section 3(a), the Mariano Lake Chapter is continued as a local chapter of the Navajo Nation Government, by the Navajo Nation Council Resolution Number CAP-34-98; and
2. Pursuant to chapter 1, subchapter 1, section 131 (1) (2) of the same "Act", the Mariano Lake Chapter has the responsibility and authority to promote, protect, and preserve the interest and general welfare, including the safety and its community people: and tanks, improved roads, telephone line and decent housing for community members, and
3. The Mariano Lake Chapter aware of the need for establishment of an Enhanced Emergency 9-1-1 System for any sudden occurrences of emergencies; and
4. The Mariano Lake Chapter acknowledges the need for establishment of an Enhanced Emergency 9-1-1 System on the Navajo Nation, to improve adequate communications and expedite emergency services; and
5. Furthermore, the Mariano Lake Chapter genuinely believes those communities within Navajo Nation will not only benefit the people, but also public businesses, health care facilities, educational institutions, fire districts, emergency rescue personnel and police district; and

#### NOW THEREFORE BE IT RESOLVED THAT:

1. The Mariano Lake Chapter hereby supports and endorses the implementation of a Rural Addressing System, commitment to help maintain the accuracy and subsequently, a Navajo Nation Enhanced Emergency 9-1-1 System, and effort by and through the Communications and Utilities Department of Navajo Division of General Services.
