RESOLUTION OF THE COPPERMINE CHAPTER OF THE NAVAJO NATION

SUPPORTING AND ENDORSING THE COMPLETION OF A RURAL ADDRESSING SYSTEM AND THE DEVELOPMENT AND IMPLEMENTATION OF A NAVAJO NATION EMERGENCY 9-1-1 SYSTEM.

WHEREAS:

- 1. Pursuant to 26 N.N.C. Section 3, and 11 N.N.C. Section 10, the Coppermine Chapter is a duly recognized and certified chapter of the Navajo Nation Government; and
- 2. Pursuant to 26 N.N.C., Chapters 1: Navajo Nation Chapters, Section 1., (B) (1) & (2), the Navajo Nation Council delegated to Chapter governmental authority with respect to local matters consistent with Navajo law, including custom and tradition and allows chapter to make decisions to govern with responsibility and accountability to community membership; and
- 3. The Coppermine Chapter is aware of the need for a Navajo Nation-wide Enhanced Emergency 9-1-1 System for any sudden occurrences of emergencies, and recognizes the lack of an effective emergency response; and
- 4. The Coppermine Chapter acknowledges the need for establishment of an Enhanced Emergency 9-1-1 System on the Navajo Nation, to improve adequate communications and expedite emergency services; and
- Futhermore, the Coppermine Chapter genuinely believes those communities within Navajo Nation will not
 only benefit the people, but also public businesses, health care facilities, educational institutions, fire
 districts, emergency rescue personnel and police district.

NOW THEREFORE IT BE RESOLVE:

 The Coppermine Chapter hereby respectfully submits its support and endorsement in the implementation of a Rural Addressing System, and subsequently, a Navajo Nation Enhanced Emergency 9-1-1 System, an effort by and through the Communications and Utilities Department of the Navajo Division of General Services
