- The LeChee Chapter hereby supports and endorses Navajo Division of General Services Communications and Utilities Department in its efforts to implement the Rural Addressing and the Enhanced Emergency 9-1-1 Systems for the entire region of the Navajo Nation.
- 2. The LeChee Chapter requests of the Communications and Utilities Department that a substation and office for this proposed system be established in Tubal City so that emergency service calls can effectively cover the western region of the Navajo (Nation!
