WHEREAS:

- 1. The Nenahnezad Chapter was certified on November 10, 1955 to make appropriate recommendations to the Navajo nation as well as to such Federal, State, County, and Navajo nation Departments as may be necessary for reviewing and approving such recommendations. Pursuant to Navajo Nation Council Resolution CAP-34-93, Nenahnezad Chapter is delegated governmental authority with respect to local matters consistent with Navajo Laws including custom, tradition, fiscal matters; and
- 2. The Nenahnezad Chapter is aware of the need for a Navajo Nation-wide Enhanced Emergency 9-1-1 System for any sudden occurrences of emergencies, and recognizes the need for the establishment of an Enhanced Emergency 9-1-1 System on the Navajo Nation to improved adequate communications and expedite emergency services; and
- 3. The Nenahnezad Chapter believes those communities within the Navajo Nation will not only benefit the people but also public businesses, health care facilities, educational institutions, fire districts, emergency rescue personnel and police districts.
- 4. The Nonahnezad Chapter also requests that the information obtained shall not be shared with commercial entities for the protection of the Navajo citizens.

NOW, THEREFORE BE IT RESOLVED THAT:

- 1. The Nenahnezad supports and endorses the completion of a Rural Addressing System and the Development and Implementation of a Navajo Nation enhanced emergency 9-1-1 System, an effort by and through the Communications and Utilities Department of the Navajo Division of General Services.
- 2. The Nenahnezad Chapter directs the Community Coordinator, Chapter officials, and the Council Delegate to carry out the intent of this resolution.
